Description: This course is designed to improve the effectiveness of speed enforcement through the use of RADAR and LIDAR speed measurement devices by training law enforcement officers in the principles, proper operation, and statutory and case law related to the operation of speed detection devices.

	entry techniques, door breaching, diversionary devices, team movement exercises, room clearance, dynamic/covert entry, entry weapon exercises, ballistic shield use, close quarters live fire exercises, and use of chemical agents.
Prerequisites:	use, crose quarters five file excretises, and use of enomical agents.
1	Must be Certified and Sworn Law Enforcement. Officers will be required to pass
	the Georgia Semi-Automatic Pistol Qualification Course with a minimum score of 90%.
	Must complete and pass physical assessment, which will be sent out when registration request is received.
