Insurance

The state lodge provides \$1,000 in life insurance coverage for all members, as well as an additional \$7,500 in accidental death coverage and an additional \$7,500 in line of duty death coverage.

These amounts are cumulative, so the benefit for an officer killed in the line of duty would be \$16,000. Other benefits related to occupational assault and disability also apply. (All coverage reduces by 50 percent at age 65.)

Through the Georgia FOP's relationship with a major national insurance company, all members are entitled to discounts on auto and homeowner's insurance policies. This frequently results in substantial savings to the member. Some members have saved enough in a year to pay their FOP dues for several years.

The Georgia FOP also has a relationship with an Atlanta area-based insurance and investment firm that provides FOP members with access to a program, designed for law enforcement officers, which is a combination of life insurance and investments. A discount is also offered to FOP members for long-term care insurance.

Discounts

In addition to savings on insurance, members have access to vendors offering discounts for mortgages, travel and merchandise.

Training

Training is provided at conferences and board meetings on current issues involving law enforcement.

Fraternalism

Membership in the FOP gives its members access to a nationwide network of law enforcement officers, which can be of great benefit both professionally and personally.

Legal Defense Plan

No law enforcement officer should be without legal defense protection. FOP members are eligible to join the FOP Legal Defense Plan.

The plan is designed specifically for the needs of law enforcement officers. The plan was designed by, is owned by and is operated by the FOP.

It provides coverage for administrative, civil and criminal action and is offered at an affordable rate. The plan also offers moonlighting liability coverage and coverage under the nationwide concealed carry law for active and retired officers.

Legislative Representation

The Georgia FOP identifies and monitors areas of concern to law enforcement and works with elected officials at the Georgia General Assembly and the U.S. Congress to affect positive results. A professional legislative representative is employed to assist with our efforts in Georgia.

On the national level, our efforts are coordinated by a full-time legislative staff with offices in Washington, D.C. The Georgia FOP also is responsible for endorsement of candidates in selected statewide elections.

Scholarships

The state lodge each year awards thousands of dollars in scholarships to members and dependents for post-high school education. Additional scholarships are available through the national lodge for spouses of officers killed in the line of duty.

Web Site

The state lodge maintains a Web site providing current information on issues involving law enforcement.
