
Legislative Update



The Legislative Committee is concentrating on the following bills/issues in the current Session of the Georgia General Assembly:

(1) Increase in P.O.A.B Benefits:

We have been working with Senator John Albers (District 56/Roswell), Senator Randy Robertson (District 29/Cataula), Homer Bryson, and others to find funding sources that will allow an increase in the P.O.A.B. That effort continues.

Talking Points for P.O.A.B.

• Total Membership: 24,083

• Eighty-three (83%) percent are City/County Officers

• Average Retirement Age: 67

Average Vested Age: 50

Average Active Age: 43

• Max payout for 30 years of service - \$ 900.00

• Average Current Payout: \$583.00

• One hundred-thirty (130) Agencies pay for Officer's P.O.A.B. dues (Which means POAB is probably the retirement for Officers).

(2) SB 328 Sponsored by Senator John Albers (District 56/Roswell)

- Defines Peace Officer with definition that aligns with POST
- Waiting period for buyback is removed
- Buyback up to 7 years (instead of 5 years)
- Buyback time counts toward vesting
- After reaching 55 or 30 years of service, member can draw benefits and remain employed.

(3) HB 451 (Sponsored by Representative Devon Seabaugh (District 34/Cobb)

This is the PTSD bill that Ashley Wilson has been working on. The bill is currently in the Insurance Committee. These are the Representatives on the Retirement committee:
